



'1st CCU Anywhere' Sweepstakes

Official Sweepstakes Rules and Regulations

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. EACH SWEEPSTAKES ENTRY WILL HAVE AN EQUAL CHANCE OF WINNING. MUST BE 18 YEARS OR OLDER TO ENTER.

- **Eligibility:** The 1st Community Credit Union '1st CCU Anywhere' Sweepstakes is open to current 1st Community Credit Union (1st CCU) members and legal residents of Wisconsin who are at least eighteen (18) years old at the time of Sweepstakes entry. Employees and Board Members of 1st CCU and their immediate family members are not eligible.
- **Sponsor:** 1st Community Credit Union, PO Box 167, 1000 W Wisconsin St, Sparta, WI 54656. Phone (888) 706-1228. Website 1stccu.com.
- **Timing:** The 1st CCU Anywhere Sweepstakes begins on April 22, 2022 at 12:00 a.m. CST and ends on May 17, 2022 at 11:55 p.m. CDT ("Sweepstakes Period").
- **How to Enter:** There are two methods of entry. Only one entry per person regardless of method of entry.
 - **Online Entry:** To enter online, Entrants must visit 1stccu.com to complete and submit the Sweepstakes Entry Form by following the one-screen instructions and filling in all required fields (name, telephone number, email address, physical address, birthdate). Online entrants must provide a valid email address and it is entrant's responsibility to update 1st CCU of any change in their email address. Online Entry Form will be available beginning on 4/22/2022 at 12:00 AM CST through May 17, 2022 at 11:55 PM CDT. To submit the online entry, visit 1stccu.com and navigate to the 'New For You In 2022' webpage listed under the Services menu. *Electronic entry forms must be completed in full on the electronic form provided. Limit one (1) entry per member. Entries using macro, robotic, script or other forms of automatic entry will be disqualified. Proof of submission does not constitute proof of receipt. The Credit Union is not responsible for late, incomplete, or inaccurate entries. If there is a dispute as to the identity of an on-line entrant, the prize will be awarded to the authorized account holder of the email address linked to the applicable entry. The "authorized account holder" is defined as the natural person to whom the e-mail address is assigned by an internet service provider, online service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted e-mail address. The Credit Union is not responsible for electronic transmission errors resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions or limitations of any kind, or inaccurate transmissions of or failure to receive entry information by the Credit Union on account of technical problems or traffic congestion on the Internet or at any Website or any combination thereof. If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Sweepstakes, the Credit Union reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes. The Credit Union reserves the right to select winners from eligible entries received as of such termination date. The Credit Union further reserves the right to disqualify any individual who tampers with the entry process. The Credit Union may prohibit an entrant from participating in the Sweepstakes if it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception or other unfair practices or intending to abuse, threaten or harass other entrants.*
 - **Alternative Method of Entry:** To enter without signing up online, an eligible entrant may legibly print his or her name, address, telephone number (including area code), and the words "1st CCU Anywhere Sweepstakes" on a 3" x 5" card and mail it in a #10 envelope with postage affixed to 1st Community Credit Union, ATTN: Marketing, P.O. Box 167, Sparta, WI 54656. Mailed entries must be received at 1st

Community Credit Union by May 17, 2022 to be eligible. *Proof of mailing does not constitute proof of delivery. Limit one (1) entry per person and limit of one entry per stamped outer envelope. Mass or mechanically reproduced entries will not be accepted. The Credit Union is not responsible for incomplete, lost, stolen, misdirected, postage-due or illegible entries or entries received after the deadline. Once submitted, entries become the sole property of the Credit Union and will not be acknowledged or returned.*

- **Description of Prizes:** There will be three (3) winners drawn, one winner for each of the three prizes.
 - **PRIZE WINNER #1 will receive a \$1000 Travel Voucher to Driftless Travel*** (1 Awarded) *Travel Voucher (Gift Certificate) is valid for new individual bookings only for Cruise/Resort/Tour within the booking capability of Driftless Travel, LLC. Certificate not redeemable for cash and cannot be divided into more than one trip. Winner must be 18 years of age or older. Travel must be booked by December 31, 2022; no extensions or exceptions will be allowed and all refunds will be made to 1st CCU and not the winner of prize.*
 - **PRIZE WINNER #2 will receive A Pair of VIP 3-Day Passes To Country Fest In Cadott, WI** (Two VIP Pass wristbands Awarded to the winner). *VIP Pass includes admission into the Concert Grounds for the entire festival. Also includes VIP parking, up-front picture taking at your leisure, a permanent bench seat, permanent bathrooms, lunch and dinner served daily at the Country Fest Café, all-you-can-drink beverages including beer, bottled water, iced tea, milk, coffee and soft drinks, as well as a convenient cash bar for those who prefer cocktails. Does not include access into the Campgrounds. Prize value of approximately \$1000. No cash substitution.*
 - **PRIZE WINNER #3 will receive a \$500 Gas Card to take you on your next road trip** (1 Awarded). *Prize to be purchased by 1st Community Credit Union. Prize value \$500. No cash substitution.*
- **Selection, Notification and Winners:** Three winners will be selected by random drawing on or around May 18, 2022. All entries submitted per the rules stated above have an equal chance of winning. Sponsor will contact each winner using the information provided on the entry form. If winner(s) do not respond within seven (7) days of notification, another name will be selected. All winners are responsible for all applicable taxes and fees. All winners will be required to present valid proof of identification when picking up their prize. Also, at that time, sponsor will take a photo of the winner(s) and Sponsor has permission to use and publish photos in any and all media for any purpose whatsoever; and include all winners' full names to identify the photos.
- **Odds of Winning:** The final number of 1st CCU Anywhere Sweepstakes entries received will determine the odds of winning.
- **Taxes:** The prize is considered taxable income, and winner will be solely responsible for any applicable federal, state, and local taxes.

The Credit Union and each of its officers, directors, employees, members, representatives and agents are not responsible for any negligence, claims, liability, injury, property loss, or other damages of entrants and/or winners arising from, or in connection with, acceptance, use, misuse, or possession of any prize awarded or participation in this Sweepstakes. The Credit Union is not responsible for any incorrect or inaccurate information, whether caused by tampering, hacking, or by any of the equipment or programming associated with the Sweepstakes. The Credit Union reserves the right to substitute a prize of equal or greater value should the featured prize(s) become unavailable for any reason. The Credit Union reserves the right to disqualify entrants who fail to follow these Official Rules or who make any misrepresentations relative to the Sweepstakes and redemption of a prize.
